- 1. Meeting called to order at 7.00pm
- 2. Commenced the day's proceedings, by singing the College song.

f. Updating the DCPPA Web:

Prof. Kodikara said that some developments to improve the web are being done and he requested others to wait till he complete this developments.

Also, committee agreed not to go ahead with the new web development.

e.Trust Fund:

Mr. Lal Premanath said that they were able to give 17 scholarships from the trust and 4 from the members who donated funds and all together 21 scholarships will be awarded on 07th December 2017. He invited all the Ex-Co members to participate to the function. He further said that Perth Group has sent Rs. 450,000/- for annual scholarship.

Mr. Jayantha Kodikara said that the Colombo Branch cannot get away from awarding scholarships when the Money is available. DCCPA –CB should participate in giving the scholarships annually in the future.

f. Status of Physical Activities:

i. Building Construction:

Chairman of the subcommittee Mr. Lal Premanath mentioned that he managed to get hold of all the subcommittee members, engineer and the contractor to a meeting an discussed the issues and the staircase issue was sorted out. He further said that there is a little improvement to the progress and the walls and columns have come up to the first floor level. The contractor agreed to complete the concreting of the first floor slab before end of November. Still the contractor has to submit the work program. He said that contractor agreed to submit an affidavit instead of extending the performance bond which is an additional cost to us.

ii. Erection of Statue

Mr. Lal Premanath reported that the Base for the statue has already been constructed and the statue will be completed and delivered to the school by end of November 2017.

He further said that there were minor adjustments to the statue to be done and the subcommittee visited and gave the approval for the final mould.

iii. Toilet work

Mr. Premanath reported that the toilets were completed for the function held on 2nd November 2017 for which H.E. the President attended.

g. Educational Excellence:

As Mr. Susiri De Silva was absent, President said that they visit the Principal at the earliest and discuss with him in this regard.

h.Status of Sports Activities:

Mr Gavesh Ginige said that a student from the school has been selected for the under 17 National Basket Ball Team.

Dr. Saveen Semage reported that he has some TT balls donated by Mr. Janaka Maduwage and President requested him to hand over them to the school on the same day at the scholarship awarding Ceremony.

Mr. Gavesh Ginige said that the Olcott Cricket Tournament will be held from 15th to 17th December at Balapitiya and 5 chief guests to be invited for the morning and evening sessions and the award ceremony. Each school will be nominated a past pupil for felicitation and we have to nominate someone from our school.

He said that the total cost will be Rs, 1.2M.

i. Accounts for the last month

The Treasurer tabled the monthly accounts for the month of October 2017.

8. Correspondence:

 at the next AGM and get approval to grant funds for this type of games too. The
 secretary was requested to send a reply to the Chess Association accordingly.

9. Any Other Business:

- i. President congratulated Mr. Saman Warusawithana for being elected to the OPA as the General Secretary on behalf of the Ex-Co. In return he thanked the Ex- co members who helped him to win the election and he said that this is the first time a General Secretary of OPA elected from Dharmasoka College after Prof; Indraratne.
- ii. It was decided to hand over the book written by Mr. Kulasena to the Editor Ms. Kumari Wickramaratne to read and do the needful.
- iii. Mr. Palitha Widanapathirana requested the Ex-Co consent to do the big match this year also by the DCPPA CB with a fund raiser. It was decided to get the Principal's approval for the same. Ex-Co requested to appoint a committee and see whether it is possible.
