5. Matters arising from Previous Meeting Minutes

5.1 Status of Physical Activities

Construction of the building

The chairman of the sub-committee for Infrastructure Development, Mr. Lal Premanath mentioned that the construction work by the contractor is satisfactory and need of another on account payment to be made to the contractor.

Treasurer Mr. Harish Guruge said that instead of withdrawing FD's, it's prudent to obtain a TOD in lien of FD to make the payment and subcommittee to decide the mode of payment.

Mr. Chandralal Sooriyaarchchi stated that he will pay his balance payment to assist the payment to contractor.

5.2 Statue of Thomas De Silva

Mr. Lal Premanath mentioned that bonze color paint is not available in the market and instead green paint can be applied with the approval of the committee. However, committee agreed to wait for the arrival of bronze color paint and complete the statue.
