# **5.1 Status of Physical Activities**

# Construction of the building

The chairman of the sub-committee for Infrastructure Development, Mr. Lal Premanath mentioned that the progress of the construction is satisfactory and the subcommittee to provide the price for the truss for the design given to the contractor.

Mr. Chandralal paid Rs.100,000/- being the balance payment of the Rs200,000/- for the building construction.

Mr. Lal Premanath mentioned that bonze color paint is still not available in the market and the contractor will try to source the paint in Bangladesh as he is presently in Bangladesh. If the bronze colour is not available, the committee decided to complete the statue in green.
